Executive Summary of Accomplishments and Evaluation for donor report (500 words maximum – to University Librarian)

Jane Nichols and Chris Snyder used \$161.98 of Lundeen funding to cover the cost of incentives and refreshments for a workshop held on May 9, 2023. We designed so participants, OSU humanities graduate students, would explore their learning needs and preferences to complete a literature review. Currently OSULP Research & Learning department regularly offers a Literature Review workshop targeted to OSU graduate students in all disciplines. The idea to hold this workshop arose after we received informal feedback by humanities graduate student about their interest in having a session targeted to their disciplinary focus.

The co-designed workshop included a beginning and closing written self-reflection in response to supplied prompts, time to review existing content and for facilitated group discussion, and an activity where participants outlined a literature review session for future students. The session, held in The Autzen Family Classroom, lasted two hours and three graduate students participated. A fourth indicated they would attend but did not. Prior to attending the session, participants completed a pre-survey where they shared their experience with conducting literature reviews and teaching or facilitating a workshop.

A preliminary review of the ending reflection shows that each participant would appreciate a workshop dedicated to humanities students. Given the session's intent and set up, this finding is both affirming and unsurprising. Further analysis will inform curricular and pedagogical changes—a quick review of suggested changes shows content to drop and to expand.

In sum this was an enjoyable method to elicit student input into modifying the literature review workshop. All appreciated the refreshments and the facilitators appreciated being able to offer participants incentives for their time and input.
